# **System Updates & Industrial Sales Report**

Wirtz gave a system update.

#### \$10 Million Loan

Wirtz reported that new \$10M loan is proposed to come from the Drinking Water Revolving Loan Fund that both R & T Water Supply Commerce Authority and WRWD will be applying separately for \$5M each. Amendments to the member agreements are being drawn up with language guaranteeing members will be responsible for repayment of the loans. The R & T and WRWD boards will have to approve the amendments to the agreements. The plan is to have it to the member boards for their July meetings.

### Armstrong

Armstrong is offering to sell their infrastructure. WAWSA may be interested in the infrastructure that would be needed to sell cold water at the 2<sup>nd</sup> Street Depot and North Williston Depot.

#### Office Building

Wirtz reported that the remodeling work on the new office building has started.

# 2017-2019 Biennium Funding

Wirtz reported that at the Grassroots Funding Committee; he informed the committee that WAWSA would be requesting \$60M for the 2017-2019 biennium. Wirtz asked the board's guidance if WAWSA was asked for a lesser dollar amount for the 2017 - 2019 biennium. The board suggested \$44M be requested as a priority.

## **Tioga Stand Tank Purchase**

Wirtz confirmed with the board the Tioga Stand Tank purchase money would be paid for with grant and loan dollars. He reported the Tioga Stand Tank was damaged by wind. An email will be sent to the City of Tioga concerning the damage and

prepare to negotiate the insurance proceeds as part of the purchase price. The City of Tioga will be asked to comply with their ordinances by publishing notice of intent to sell the property.
