# **System Updates & Industrial Sales Report**

Wirtz gave system updates.

#### **Industrial Sales**

The industrial sales for May were \$689,494.00.

# **NDIC Meeting**

Wirtz reported on the June  $5^{th}$  NDIC meeting. Wirtz reported that the NDIC has allowed an extension of the 5 year contracts for maintenance water connections to 10 years if needed. A committee to study the feasibility of privatizing the depots has been created.

#### **State Water Commission**

The SWC will meet on June  $22^{nd}$ . The WRWD 1804 East Transmission project is on the agenda to be moved to Phase 4 so the current grant money may be used to fund the project. It is intended that a portion of the 2017-2019 biennium grant money will be allocated at the August SWC meeting.

## **Future Loan Funding**

Wirtz reported that the DWSRF loans for R & T and WRWD should be finalized soon. MCWRD may be asked to apply for a \$10M DWSRF loan in the future to match against future grant dollars.

## **Wagner Construction Update**

Wirtz reminded the board that Wagner Construction has three bores on the Watford City South By-Pass project that are out of compliance and that the board had made a motion last month to have Wagner replace the three bores in question. Wagner asked for an alternative to replacing the bores. After board discussion, the motion from the May meeting stands and bores will need to be replaced.

## **Joint Powers Agreement**

Wirtz presented the Joint Powers Agreement; the purpose for the agreement is for BDW, WRWD and R & T to define their respective service and operational boundaries within the WAWSA system. **Zubke made a motion for WAWSA to sign off on the Joint Powers Agreement, Koeser seconded.**
