# **Executive Director's Report**

# **Industrial Sales**

The industrial sales for June were \$1,236,053.00.

# **System Updates**

Pokrzywinski gave system updates.

#### **State Water Commission**

The SWC met on June 22<sup>nd</sup>. Owan reported that at the last State Water Commission the Governor asked for everyone's resignation. The Governor asked for three of the commissioner to remain. Owan reported that he would be submitting his application for the commission. Chorne reported that a letter will be sent to the SWC requesting WAWSA be allocated money at the August meeting for projects that are ready to construct. If money is not allocated at the August meeting, construction on new projects will be delayed until next year.

#### City of Ray

WAWSA contracted with Utility Systems of America (USA) for the construction of the "Tioga High Point to Tioga Transmission Main & Ray Transmission Main" project. As part of this project, WAWSA designed "Tower Fill Piping Modifications" to include a meter and control valve inside the City of Ray's tank shaft. USA bid \$41,000.00 on this item. Due to construction scheduling issues, this item was removed from USA's contract. The City agreed to use \$23,218.43 worth of parts intended for this work, and have PFE perform the installation under their contract with the City. For this item, the City of Ray would like to be reimbursed in an amount equal to what was allocated for the fill piping modifications minus the cost of the parts which were already purchased: \$41,000.00 - \$23,218.43 = \$17,781.57. Upon confirming the cost of the parts with AE2S, WAWSA was notified that the parts total was \$24,127.75 and the amount due the City of Ray would be \$16,872.25. Veeder made to pay the City of Ray the \$16,872.25 for their construction cost, Koeser seconded.

The City of Ray also asked for cost share on the telemetry and controls on the new water tower they are constructing as this will benefit R & T and WAWSA. Schultz stated that AE2S would review this item and let the board know what would be WAWSA's portion of this expense. The board will consider the request when more information is available.

# **Armstrong Water Solutions**

The board was notified that the MDU Deficiency payment for March 2016 – February 2017 was \$104,292.00. Armstrong was reimbursed from the escrow account by BND as per the Escrow Agreement.

## **Employee Compensation**

Second quarter employee bonus evaluations have taken place. Chairman Owan recommended a 9% 2nd quarter bonus for Executive Director Jaret Wirtz. Koeser moved to give Wirtz a 9% 2ndquarter bonus based on Chairman Owan's recommendation, Brostuen seconded.
