#### **Executive Director Report**

Madsen gave a monthly update on water usage and WAWSA system operations.

#### **Member Weighted Voting**

As per the WAWSA Bylaws, every three years the Average Annual Water Volume shall be determined and the number of additional votes of each Appointed Director recalculated. Each director receives one vote plus the additional votes. The votes per member entity are BDW 3 votes (1.5 votes per director), City of Williston 17 votes (8.5 votes per director), R&T 5 votes (2.5 votes per director), MCWRD 7 votes (3.5 votes per director), and NWRWD 4 votes (2 votes per director) for a total of 36 votes.

## **SWC/NDIC Updates**

Madsen reported that WAWSA has several items on the NDIC February agenda. She reported that she will be presenting a reimbursement request for Industrial improvements for meter trailers and other repairs/maintenance to close out 2022, a budget for Industrial system improvements planned for 2023, the 2023 WAWSA Industrial budget, the 2023 Industrial reimbursement rates for the Member Entities, and a summary of the 2022 activities of the Industrial utility.

Madsen also reported that she will be providing testimony on January 19, 2023, on SB 2020.

Tom Klabunde presented the board with an update on the 29-Mile Project.
