Resolution Approving Issuance

WHEREAS, the Western Area Water Supply Authority (the "Authority") pursuant to the authority granted in House Bill 1206 of the 2011 Legislative Session determines it to be in the public interest to issue up to \$25,000,000 Western Area Water Supply Authority, Utility System Revenue Notes, Series 2011A (the "Note") for the purposes of (i) financing the construction of a water distribution system and (ii) paying the costs of issuance; and

WHEREAS, the following documents have been prepared in connection with the issuance, sale and delivery of the Note and have been reviewed by the officers and legal counsel of the Authority:

- (a) Indenture of Trust, dated as of September 1, 2011 (the "Indenture"), between the Authority and the Bank of North Dakota, as Trustee (the "Trustee");
- (b) Series 2011A Supplemental Indenture, dated as of September 1, 2011, relating to the Note, between the Authority and the Trustee (the "Supplemental Indenture" and together with the Indenture, the "Indentures"); and
- (c) Commitment Letter, dated September 16, 2011 from the Bank of North Dakota (the "Commitment Letter" and together with the Indentures, the "Financing Documents").

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

Section 1. Approval and Authorization. The Authority through its Board of Directors (the "Board") hereby finds and determines that the Note shall be sold to the North Dakota State Water Commission upon the terms and conditions set forth in the Financing Documents in an amount not exceeding \$25,000,000, at a price not less than 100% of the principal amount thereof and at an interest rate of 0.00%. The Financing Documents, in substantially the forms on file with the Board office are hereby approved. The Chairman and Secretary are authorized and directed to execute the Financing Documents for and in the name of the Authority subject to the limitations set forth above and in substantially the form on file with the Board office but with such changes, insertions or omissions therein as shall be approved by the officers executing such Financing Documents upon advice of counsel to the Board, the approval of such changes to be evidenced conclusively by such execution of the Financing Documents.

Section 2. <u>Authorized Officers</u>. The Board hereby appoints the Chairman, Secretary and Manager as the Authorized Officers jointly or severally to carry out and to perform the obligations of the Board contained in the Financing Documents.
